Cookies

To make this site work properly, we sometimes place small data files called cookies on your device. Most big websites do this too.

What are cookies?

A cookie is a small text file that a website saves on your computer or mobile device when you visit the site. It enables the website to remember your actions and preferences (such as login, language, font size and other display preferences) over a period of time, so you don't have to keep re-entering them whenever you come back to the site or browse from one page to another.

How do we use cookies?

We use cookies and other technologies to ensure everyone who uses our website has the best possible experience. Cookies also help us keep your account safe. By agreeing to this cookie notice, you are agreeing to the use of cookies and similar technologies for the purposes we describe in this policy.

We use two types: persistent cookies and session cookies. A persistent cookie helps us recognize you as an existing user, so it's easier to return to our site or interact with our services without signing in again. After you sign in, a persistent cookie stays in your browser and will be read when you return to our site. Session cookies only last for as long as the session (usually the current visit to a website or a browser session).

Cookies we use on this site can be broken down into five main categories:

Authentication: If you're signed in to our site, cookies help us show you the right information and personalize your experience.

Security: We use cookies to enable and support our security features, and to help us detect malicious activity and violations of our User Agreement.

Preferences: Cookies can tell us which language you prefer and what your communications preferences are. They can help you fill out forms on our site more easily. They also provide you with features, insights, and customized content.

Advertising: We may use cookies to show you relevant advertising both on and off the site.

Analytics: Cookies help us learn how well our site performs.

How to control cookies

You can **control and/or delete** cookies as you wish – for details, see <u>aboutcookies.org</u>. You can delete all cookies that are already on your computer and you can set most browsers to prevent them from being placed.
